### MINUTES OF ANNUAL BUSINESS MEETING

#### Minutes of the Annual Business Meeting Sunday, March 26, 203 @ 6:00 p.m. Held in the Sanctuary

The meeting was called to order and opened in prayer by Pastor Tracy at 6:02pm.

A quorum was established with 38 members in attendance in person, out of a possible 59. There were four nonmembers in attendance.

**Moved** by Ben Benninger, **Seconded** by Joel Bromley that a mixed voting bar be comprised of all present in the front of the room. **Carried.** 

**Moved** by Juno Park, **Seconded** by Joshua Kubassek that Kaitlin Bromley be appointed the recording secretary. **Carried**.

**Moved** by Jack Sousa, **Seconded** by Matt Jamieson that the minutes from the March 27, 2022 Annual Business Meeting be accepted as printed and distributed. **Carried.** 

#### **Election of Board Members**

This year we will have five members on our Board of Deacons, comprised of three members with one year remaining on their term (Walt Kippenhuck, Jamie Steckley and Jack Sousa) and two members to be elected by secret ballot at this meeting. 50% of votes are needed in order to be elected.

**Moved** Walt Kippenhuck, **Seconded** by Jack Sousa that Katie Winger, Pernilla Snethlage and Joel Bromley be appointed as Scrutineers. **Carried**.

After our nominating process in January, the four eligible candidates for election to the Board of Deacons are: Jim Klujber, Joshua Kubassek, Juno Park and Julie Schroth (alphabetical by last name).

Secret ballots were distributed to the members and collected by scrutineers.

#### **Presentation of Annual Reports**

Pastor Tracy made comments highlighting 2022 and looking ahead to 2023.

Pastor Erin Jamieson made comments highlighting our community ministry, the success of the Pavilion Project and further needs to grow the ministry use of the building.

#### **First Ballot Report**

Vote results:

No election determined. Secret ballot votes were distributed to the members and collected by scrutineers.

#### Presentation of Annual Reports - cont'd

Margaret Pfeiffer and Ethan Elka shared highlights from their areas of ministry.

Pastor Tracy gave an update that Margaret Pfeiffer will continue to be fully engaged in our children's ministry until she leaves for Guatemala as a global worker; approximately one year until her Global Worker training will be complete.

Moved by Jim Klujber, Seconded by Jack Sousa that the 2022 Annual Reports be accepted as printed. Carried.

#### Second Ballot Report

Vote results:

No election determined. After second vote, nominee with lowest number of votes must be removed – Josh Kubassek was be taken off ballot. Secret ballot votes were distributed to the members and collected by scrutineers.

#### Welcome to Our House & Property Development Report

Pastor Tracy gave updates on Welcome to Our House, the land exchange agreement and capital projects budget.

#### Welcome to Our House

Pavilion was the final WTOH project.

#### Land Exchange Agreement

- Landscaping will be completed when construction begins on the townhouses that will be built on the exchanged land.
- Next steps: engineering for sewer, water and sanitary lines, followed by seeking approvals from the City.
- A new driveway is not going to be possible for several years. The road will have to be assumed by the City before we can apply for access.
- Bleams Road is scheduled to be widened in 2024.

#### **Capital Projects Budget**

- We have an aging building that needs some upgrades.
- A capital projects budget is continuing to be worked on for these upgrades which includes, but is not limited to:
  Sanctuary (lights, stage, sound booth, paint)
  - Fellowship Hall (multi-purpose, painting)
  - HVAC units (20+ years old)
  - Washrooms

Questions were asked and answered.

#### Presentation of the 2022 Financial Report

Mary Lynn Benninger presented the 2022 financial report.

Questions were asked and answered.

**Moved** by Mary Lynn Benninger, **Seconded** by Joe Renner that the 2022 financial report be accepted as printed and presented. **Carried.** 

Pastor Tracy thanked Mary Lynn Benninger, Katie Winger and Joshua Kubassek for serving on the Finance Committee.

#### **Final Ballot Report**

Vote results:

No election determined so lowest number of votes drops off ballot (Juno Park).

The Board of Deacons will be comprised of Jack Sousa, Jamie Steckley, Walt Kippenhuck and newly elected members: Jim Klujber and Julie Schroth.

Jim Klujber and Julie Schroth addressed the people.

Pastor Tracy thanked Juno Park and Joshua Kubassek for allowing their names to stand for election to the Board of Deacons.

#### Motion for Ballots to be Destroyed.

Moved by Laura Schofield, Seconded by Joshua Kubassek that ballots be destroyed. Carried.

#### Presentation of 2023 Budget

Pastor Tracy presented the 2023 budget and highlighted some of the goals for the year.

- \$443,000 General Fund income is a 7% increase over last year's budget in alignment with inflation.
- 70% decrease to Kingdom Expansion Fund due to Pavilion being mostly completed.
- 7% increase to staff includes 3% staff increases and Ethan came on full time during 2022.
- 100% increase in Church Upgrades (2023 capital projects)
- All together total expenses have decreased 34%

**Moved** by Jim Klujber, **Seconded** by Walt Kippenhuck that the 2023 budget be accepted as printed and presented. **Carried.** 

#### **General Operating By-Law Number 1 Motion**

Updates to the General Operating By-Law require a 75% vote from the membership to pass. Amendments were sent to the membership 30 days ago for consideration.

Be it Resolved as a special resolution that:

1. The General Operating By-law of the Corporation (as amended) is repealed and the new General Operating By-law No. 1 which has been submitted to this meeting and is annexed to these minutes as Schedule A is approved and will be effective as of the date set out below.

2. Any one of the officers and directors of the Corporation is authorized to take all such actions and execute and deliver all such documentation which are necessary or desirable for the implementation of this resolution.

Moved by Julie Schroth, Seconded by Jack Sousa that motion be accepted.

Pastor Tracy provided an explanation of the updates:

This resolution will update our General Operating By-Law and exchange "Statement of Fundamental and Essential Truths" for "Statement of Essential Truths" throughout the document. The Pentecostal Assemblies of Canada has refreshed and updated this document, including its title. It was approved by the conference in May 2022. This change is noted in 2.03, 4.01(d) and 6.04(b).

#### Motion is **Carried**.

**Moved** by Margaret Pfeiffer, **Seconded** by Dave Hancock that appreciation for all ministry volunteers be expressed. **Carried.** 

Moved by Matt Jamieson, Seconded by Brad Schroth that the meeting be adjourned. Carried.

Pastor Tracy closed in prayer at 7:17pm.

## LEAD PASTOR'S REPORT

Life goes by fast and church life is no exception. We can be quick to move on to what's next or what is calling for our attention and forget to celebrate all that God has done at Freedom in the past year. With that in mind, I took a few moments to scan back through my 2023 calendar and found myself smiling as I remembered some of the highlights.

All through 2023, our 5th Sundays were themed around generations. I don't think I'll ever forget the older generations teaching their kids and grandkids how to use the hymn books we borrowed in January. It was even better than I'd imagined. And then as our kids and youth led services throughout the year, God's faithfulness through all generations was fully on display.

In the spring we had a Lead Summit with our Board, Staff, and spouses to take stock of ministry and mission at Freedom. This is always a high point for me because this group of people are such a joy to work alongside. We dug in on discipleship and evangelism, challenging ourselves in both of these key areas and strategizing how we could strengthen them. Looking back, I can see how this has helped to shift our culture in encouraging ways. It's also the reason that we implemented the Sunday Debrief group and Life Shared seminar last year.

The summer brought us a lot of work and it was more than worth it. We did a refresh of the Sanctuary and Fellowship Hall, taking care of these important gathering spaces so they are ready for many more years of ministry to come. Many thanks to our defacto project manager, Matt Jamieson, and for everyone who lent their time and skill to the project.

Throughout the fall we hosted Sunday Night Conversations around gender and sexuality. As challenging as these topics can be, I was astounded by the grace and compassion that was present in the room, even as we worked through different viewpoints and experiences. Let's continue to hold that kind of respect for the Word and one another as God's image bearers. It is beautiful.

Our missions giving lagged behind our goal all year long and I wondered what our year-end would look like. After serving the Lord all these years I should know not to be surprised, I admit that I could hardly believe it when we ended the year with a \$9,000 surplus in missions. We were able to bless our missions partners over and above what we had committed to them and put over \$5,000 toward our 2024 commitment of \$14,000 to Margaret. Praise the Lord! All of this was happening while our General Fund had a surplus of around \$35,000. Simply amazing. God is using us to expand His kingdom when we are faithful, generous stewards.

I'm glad we're doing this together, obediently staying in step with the Spirit, listening to what He has for us to do and following His leadership. Thank you for your commitment to unity, to His church, and to being faithful each day. The work we are doing will matter for eternity.

Every Sunday morning in Kids Church we engage in various activities, including Bible learning, small group discussions, exciting games, and fostering connections among the children. It is through these activities that we are creating enriching spiritual experiences that equip our kids to grow in their faith and develop a deeper relationship with God.
